enclosed spaces, SCBA. Firefighters should wear proper protective equipment and self-contained breathing apparatus with full face piece operated in positive pressure mode.

Special fire-fighting procedures: Move containers from fire area if safe to do so. Use water spray to cool unopened containers. Avoid spreading burning liquid with water spray used for cooling purposes. Do not allow run-off from fire fighting to enter drains or water courses. Prevent fire extinguishing water from contaminating surface water or the ground water system. Dike for water control.

#### SECTION 6. ACCIDENTAL RELEASE MEASURES

#### Personal precautions, protective equipment and emergency procedures:
